Each recipient will receive:

- Computer and Software (installed)
 - Monitor
 - Keyboard
 - Mouse
 - Windows XP Professional
 - Firefox – Internet browsing
 - Open Office
 - Adobe Reader
 - AVG (Antivirus)
 - AdAware (Spyware removal)
- Assistance with setup and hands on instructions for the operation of your computer (by a local youth group).

PCs for People warrants equipment for 90 days (hardware) and will replace it if it's not functional. After the 90-day warranty, PCs for People will make repairs for \$25.00. Shipping not included.

A free-will donation between \$25 -\$50 is requested for computers (the more- the newer, laptops are more). One computer per family.

Included with the computer is a reduced rate high-speed internet package. The first 24 recipients will receive one year of WindomNet's High Speed Lite Internet package at a reduced rate of \$10 per month. (To qualify for this offer, individual must not currently have WindomNet Internet lite or higher pkg)

Also included is a free one-year subscription to **Atomic Training** (a part of Atomic Learning).

Atomic Training will provide access to on-line tutorials for a multitude of computer program applications.

Who is eligible?

1. You are eligible if you receive benefits from any of the following program(s):

- * Medicaid/Medical Assistance
- * Food Support (food stamps)
- * Federal Public Housing or Section 8 Assistance
- * MN Family Investment Program (MFIP)
- * Supplemental Security Income (SSI)
- * Low-Income Home Energy Assistance Program (LIHEAP)
- * Temporary Assistance to Needy Families (TANF)
- * National School Free Lunch Program
- * Bureau of Indian Affairs General Assistance
- * Tribally administered Temporary Assistance
- * Tribally Administered Head Start (for those meeting income qualifying standard)

2. You are eligible if you do not receive benefits from any of the programs listed above, BUT your income is at or below 150% of Federal Poverty Guideline. One of the following documents is needed, you're your application.

- * Last year's State, Federal or Tribal Tax Return
- * Current annual income statement from Employer
- * Paycheck stubs for most recent 3 consecutive months.
- * Social Security Benefits Statement
- * Veterans Administration Benefits Statement
- * Retirement/Pension Benefits Statement
- * Unemployment/Workmen's Compensation
- * Divorce Decree Statement
- * Child Support Document
- * Other
